### COVID-19 SECURE RISK ASSESSMENT FOR REOPENING SEPTEMBER 7<sup>th</sup>, 2021

The purpose of this risk assessment is to ensure that the risks from Covid-19 continue to be managed effectively to help protect our staff, pupils, and the rest of the school community during the pandemic. We understand that we are legally required to think about the risks staff and pupils face and do everything reasonably practicable to minimize these risks.

All year groups up to and including Year 6 should return to face-to-face education on 8th March. If required, year groups from Year 7 – Year 11 may undergo a phased return of pupils in the week commencing 8th March to allow for testing that week.

We understand that we have a legal duty to consult with staff on health and safety in good time. We may also involve pupils and parents in some discussions to help them understand the measures that are being put in place. We will share the risk assessment with staff and publish it on our website to provide transparency for pupils and parents – HSE expects all employers with over 50 staff to do this.

The SMT and site manager have paid strict attention to the DfE's ['Actions for schools during the coronavirus outbreak'](#) and ['Health and safety: responsibilities and duties for schools'](#) to inform the decisions on what control measures should be implemented.

## 1) AWARENESS OF POLICIES AND PROCEDURES

Risk rating prior to action – **HIGH**

Risk Rating following controls - **MEDIUM**

### Control Measures

- All staff and volunteers are aware of all relevant policies and procedures, including, but not limited to, the following: *Covid-19 Full Opening Plan (September, 2021)*, *Covid-19 Full Rapid Testing Policy (March 1st, 2021)*, *Health and Safety Policy*, *Infection Control Policy*, *Social Distancing Policy*, *First Aid Policy*, *Behavioural Policy*
- Pupils are supported to understand and follow the relevant school policies and procedures, including, but not limited to, the following: *Health and Safety Policy*, *Infection Control Policy*, *Social Distancing Policy*, *Behavioural Policy*
- All staff have regard to all relevant guidance and legislation including, but not limited to, the following:
  - The Health Protection (Notification) Regulations 2010
  - The Reporting of Injuries, Diseases and Dangerous Occurrences Regulations (RIDDOR) 2013
  - Public Health England (PHE) (2017) 'Health protection in schools and other childcare facilities'
  - DfE (2021) 'Schools coronavirus (COVID-19) operational guidance (applies from step 4)'
  - **[Early years settings]** DfE (2021) 'Actions for early years and childcare settings during the coronavirus (COVID-19) outbreak (applies from Step 4)
  - DfE (2021) 'Use of PPE in education, childcare and children's social care'
- Staff receive any necessary training on measures that have been implemented that are relevant to their role, e.g. infection control and pupil wellbeing.
- The school keeps up-to-date with advice issued by, but not limited to, the following:
  - DfE, NHS, PHE, Department of Health and Social Care
  - The school's local health protection team (HPT)
- All staff, volunteers, parents, pupils, visitors and contractors are made aware of relevant infection control and other measures in place via **ParentMail**, particularly any changes to processes to allow for the full opening of the school.
- Pupils are made aware of the measures that are in place, e.g. infection control and behaviour expectations, via various methods, including visual aids around the school and reminders from staff.
- The **SBM** conducts a review of all supplier and contractor arrangements to ensure they are appropriate for the school's current operations.
- The **SMT** reviews relevant school policies to ensure they account for new provisions.

<b>2) MINIMISING CONTACT WITH POTENTIAL OR CONFIRMED CORONAVIRUS CASES</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• <b>[Updated]</b> Pupils, staff and other adults do not enter the school premises if: <ul style="list-style-type: none"> <li>- They have any symptoms of coronavirus.</li> <li>- They have tested positive for coronavirus in the last 10 days.</li> <li>- They are required to quarantine having recently visited countries outside the <a href="#">Common Travel Area</a>.</li> </ul> </li> <li>• <b>[Updated]</b> Parents are informed via <a href="#">ParentMail</a> not to bring their children onto the school premises if they show symptoms of, or have tested positive for, coronavirus.</li> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change in sense of smell or taste, and a high temperature, and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Staff, parents, pupils and visitors are informed of the national legal requirements regarding self-isolation, including that if they are required to self-isolate, this must be for a full 10 days from the start of their symptoms, or the date of their positive test if they did not have symptoms.</li> <li>• <b>[New]</b> Pupils and parents are made aware that, from 16 August 2021, pupils under the age of 18 will no longer be required to self-isolate if they are identified as a close contact of a positive case. Instead, pupils will be advised by NHS Test and Trace to take a PCR test and will only need to isolate if they produce a positive test.</li> <li>• <b>[New]</b> Pupils and parents are made aware that, from 16 August 2021, fully vaccinated adults who are identified as a close contact of a positive case will not need to self-isolate unless they develop symptoms or produce a positive test, as long as they are fully vaccinated.</li> <li>• <b>[New]</b> Staff who have only had one dose of the vaccine are made aware that they still need to self-isolate if identified as a close contact until two weeks after receiving their second dose.</li> <li>• Instances of staff, pupils, visitors and volunteers displaying symptoms of coronavirus are managed in line with local and national guidance and the <a href="#">Infection Control Policy</a>.</li> <li>• <b>[New]</b> Pupils and parents are made aware that, from 16 August 2021, staff and students over the age of 18 will follow the same self-isolation rules as those under 18 until four months after their 18<sup>th</sup> birthday, at which point they will begin to follow the same rules as adults. This time should be used to ensure they are vaccinated if possible.</li> <li>• <b>[Updated]</b> If anyone in the school develops coronavirus symptoms while at school,</li> </ul>	

they are:

- Sent home to begin isolation – the isolation period includes the day the symptoms started and the next 10 full days.
  - Advised to follow the guidance for households with possible or confirmed coronavirus infection.
  - **[Updated]** Advised to arrange a PCR test as soon as possible.
- 
- Pupils being sent home after displaying symptoms who are awaiting collection by a parent are moved to a room where they can be isolated behind a closed door, with an open window for ventilation where possible. If it is not possible to isolate the pupil, they are moved to an area which is at least two metres away from others. If required, a member of staff supervises the pupil.
  - Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in government guidance and the [Infection Control Policy](#).
  - In exceptional circumstances, where a pupil's parents cannot arrange to have their child collected, if it is age-appropriate and safe to do so, the child is directed to walk, cycle or scoot home. If this is not possible, the school makes alternative arrangements.
  - Symptomatic individuals who are sent home are directed to not use public transport to get home.
  - If the pupil needs to use the toilet while awaiting collection, they use a separate bathroom if possible. The bathroom is cleaned and disinfected using standard cleaning products before being used by anyone else.
  - Emergency assistance is called immediately if the pupil's symptoms worsen and they require further medical care.
  - PPE is worn by supervising staff if direct personal care is needed and they cannot maintain a distance of two metres.
  - Anyone who comes into contact with a symptomatic individual washes their hands thoroughly for 20 seconds with soap and running warm water or hand sanitiser. The area around the symptomatic individual is cleaned with normal household bleach after they have left the premises.
  - Staff members who have helped someone with symptoms and any pupils who have been in close contact with them are informed that they do not need to self-isolate unless they develop symptoms themselves.
  - The school does not routinely take the temperature of pupils. The school refuses to admit a pupil who is displaying symptoms of coronavirus where their parents are insisting their child attends if, in its reasonable judgement, the pupil poses a risk of infection to other members of the school community.

<b>3) FACE COVERINGS</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• <b>[New]</b> Staff, pupils and visitors are informed via <a href="#">ParentMail</a> that they are not required to wear face coverings at all in school.</li> <li>• <b>[New]</b> In the event of a school or local outbreak, the school adheres to advice from a director of health that may include bringing back face coverings temporarily in communal areas and classrooms for staff, pupils and visitors.</li> <li>• <b>[Updated]</b> In the event that the school must return to using face coverings, the school remains sensitive to the fact that some people are less able to wear face coverings and that the reasons for this may not be visible to others.</li> <li>• Transparent face coverings, which may assist communication with someone who relies on lip reading, clear sound or facial expressions to communicate, are worn where appropriate.</li> <li>• Face visors or shields are not worn as an equivalent alternative to face coverings; however, they can be worn by those exempt from wearing face coverings.</li> <li>• Face visors or shields are only used after carrying out a risk assessment for the specific situation and always be cleaned appropriately.</li> <li>• Individuals are provided with clear instructions on how to put on, remove, store and dispose of face coverings. This includes instructions to: <ul style="list-style-type: none"> <li>- Clean hands before and after touching a face covering.</li> <li>- Store face coverings in individual, sealable plastic bags.</li> <li>- Avoid wearing damp face coverings.</li> </ul> </li> <li>• <b>[Updated]</b> Where face coverings are required, individuals are not prevented from entering or attending school on the grounds that they are not wearing a face covering.</li> <li>• The school has a contingency supply of face coverings.</li> <li>• Anyone struggling to access a face covering, or unable to use their face covering because it has been forgotten or soiled, is provided with one from the school's contingency supply.</li> <li>• <b>[New]</b> Face coverings should be worn in enclosed and crowded places – this includes on school transport.</li> </ul>

<b>4) PPE</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• PPE is distributed to staff who provide intimate care for pupils who need this care and for cases where a pupil becomes unwell with symptoms of coronavirus whilst in school and a distance of two metres cannot be maintained.</li> <li>• Additional risk assessments are conducted on a case-by-case basis to determine whether staff require PPE to carry out other tasks and duties.</li> <li>• When working with pupils who cough, spit or vomit but do not have coronavirus symptoms, staff only wear PPE that would routinely be worn.</li> <li>• Used PPE is disposed of properly using bins provided around the school. Staff and pupils are told not to use recycling bins for the disposing of PPE.</li> <li>• All PPE waste is put in a plastic rubbish bag which, once full, is tied and placed in a second tied bag and stored in a suitable and secure place, marked for storage for 72 hours. Following this period, it is put in the communal waste area.</li> </ul>

<b>5) HAND CLEANING AND RESPIRATORY HYGIENE</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• <b>[New]</b> Staff, pupils, visitors and contractors are informed via <a href="#">ParentMail</a> that enhanced hygiene practices are still in place during step 4.</li> <li>• Suitable handwashing facilities are provided for individuals to wash their hands regularly and at the following intervals: <ul style="list-style-type: none"> <li>- Arrival at school</li> <li>- Return from breaks</li> <li>- A change in rooms</li> <li>- Before and after eating</li> </ul> </li> <li>• The school considers how often pupils and staff need to wash their hands and time for this is incorporated into timetables and lesson plans, allowing for additional opportunities for some staff and pupils to wash their hands more frequently, e.g. pupils who use saliva as a sensory stimulant.</li> <li>• There is an adequate amount of handwashing stations, which are kept well-supplied with soap and running water or hand sanitiser.</li> <li>• Adequate amounts of tissues and bins are available in the relevant areas.</li> <li>• Skin-friendly sanitising wipes are used as an alternative for pupils who are at risk of ingesting hand sanitiser, where appropriate.</li> <li>• Visual aids are displayed throughout the school reminding pupils to wash their hands regularly and follow the 'catch it, bin it, kill it' approach.</li> <li>• A plan is created to assimilate the hand-washing routine and 'catch it, bin it, kill it' approach into school culture, supplemented by behaviour expectations and communication around the importance of the measures.</li> <li>• Pupils are supervised, where appropriate, when using hand sanitiser to ensure they do not ingest any.</li> <li>• Pupils are instructed to cough or sneeze into their inner elbow and use a tissue to cover their mouths and noses where possible, disposing of the tissue in lidded bins.</li> <li>• Pupils wash their hands after they have coughed or sneezed.</li> <li>• Younger pupils and those with complex needs are supported to ensure they adopt good hand cleaning and respiratory hygiene practices.</li> <li>• Individual risk assessments are conducted for pupils with complex needs who struggle to maintain good respiratory hygiene.</li> </ul>	
<b>Are these controls now in place? – YES</b>	<b>By whom? SMT &amp; Site Manager</b>

<b>6) CLEANING</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• <b>[New]</b> The school maintains an appropriate cleaning schedule which includes the regular cleaning of areas and equipment e.g. twice per day. There is a particular focus on frequently touched surfaces.</li> <li>• The <b>site manager</b> implements a cleaning schedule that ensures cleaning is generally enhanced and includes: <ul style="list-style-type: none"> <li>- More frequent cleaning of rooms and shared areas (including classrooms, playgrounds and eating areas) that are used by different groups.</li> <li>- Frequently touched surfaces being cleaned more often than normal.</li> <li>- Provision for ensuring toilets are cleaned regularly.</li> </ul> </li> <li>• Dining areas are cleaned between use by different pupil groups, known as 'bubbles'.</li> <li>• Where necessary, the number of rooms used by staff and volunteers is limited to avoid the spread of infection.</li> <li>• The necessary areas of the school are deep cleaned with suitable cleaning agents and in line with the <b>COSHH Policy</b>.</li> <li>• All areas that have been cleaned are checked to ensure they are safe to occupy, e.g. there are no slip hazards and any harmful substances have been removed.</li> <li>• All areas that remain temporarily closed, or partially closed for cleaning or infection control purposes, are clearly signposted.</li> <li>• Adequate amounts of suitable cleaning agents are available.</li> <li>• PPE is available to members of staff who require it to carry out cleaning safely.</li> <li>• Signs are placed in relevant areas to instruct staff and pupils to always flush toilets with the lids down.</li> </ul>	
<b>Are these controls now in place? – YES</b>	<b>By whom? SMT &amp; Site Manager</b>

<b>7) SOCIAL DISTANCING</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• <b>[Updated]</b> The <b>Social Distancing Policy</b> is shared with all relevant members of the school community and adhered to where required e.g. around a symptomatic individual.</li> <li>• <b>[New]</b> Staff and pupils are informed they no longer need to adhere to social distancing measures in school unless directed.</li> <li>• <b>[New]</b> Pupils are informed they no longer need to be separated into bubbles in school.</li> <li>• <b>[New]</b> In the event of a school or local outbreak, the school adheres to the advice of a director of public health, which may include returning to social distancing measures, including pupil bubbles, temporarily.</li> </ul>	
<b>Are these controls now in place? – YES</b>	<b>By whom? SMT &amp; Site Manager</b>

<b>8) RESOURCES</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• Staff and pupils have their own individual and frequently used items, e.g. pencils and pens.</li> <li>• <b>[Updated]</b> Classroom resources, e.g. books and games are cleaned regularly.</li> <li>• Pupils only bring essential items to school each day, e.g. lunch boxes, hats, coats, books, stationery and mobile phones.</li> <li>• Pupils are permitted to bring bags to school.</li> <li>• Any shared resources that need to be taken home by pupils and staff are appropriately cleaned or a rota is put in place.</li> </ul>	
<b>Are these controls now in place? – YES</b>	<b>By whom? SMT &amp; Site Manager</b>

<b>9) VENTILATION AND HEATING</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• <b>[New]</b> Staff and pupils are made aware that enhanced ventilation is still in place during step 4.</li> <li>• The <b>site manager</b> checks that all ventilation systems, including fume extraction systems, are in working order in accordance with manufacturer’s recommendations, and that there are no blockages present in external or internal vents.</li> <li>• All ventilation systems remain energised in normal operating mode.</li> <li>• Where mechanical ventilation is used, recirculatory systems are adjusted to full fresh air where possible.</li> <li>• Ventilation to chemical stores remains operational.</li> <li>• Where possible, the windows of occupied rooms are open. In cold weather, where this causes issues with thermal comfort, the following mitigations are put in place where possible: <ul style="list-style-type: none"> <li>- Classrooms are rearranged to minimise the discomfort caused by draughts from open windows, e.g. by moving desks and chairs</li> <li>- High level windows are opened in preference to low level to reduce draughts</li> <li>- Ventilation is increased while the space is unoccupied, e.g. during break- and lunchtimes</li> </ul> </li> <li>• The relevant staff adjust any thermostats to heat internal spaces and water, ensuring a suitable stable temperature is maintained.</li> <li>• Where heating has been switched off or energy supplies for heating have been isolated, a suitably trained individual switches them back on, as required.</li> </ul>	
<b>Are these controls now in place? – YES</b>	<b>By whom? SMT &amp; Site Manager</b>

<b>10) FIRE SAFETY</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• The <b>site manager</b> ensures that all fire detection and alarm system, fire extinguisher and sprinkler checks are up-to-date.</li> <li>• The <b>SBM</b> and <b>Principal</b> ensure that the fire management plan and fire safety risk assessment are up-to-date and applicable to any changes in people movement or access, e.g. if parts of the school remain temporarily closed.</li> <li>• <b>[Updated]</b> Where directed, the <b>Principal</b> identifies how social distancing measures are to be observed at evacuation points and communicates this to all staff, volunteers, pupils, parents and contractors.</li> </ul>

<b>11) OPENING AFTER REDUCED OCCUPANCY</b>	
<b>Risk rating prior to action – HIGH</b>	<b>Risk Rating following controls - MEDIUM</b>
<b>Control Measures</b>	
<ul style="list-style-type: none"> <li>• The <b>site manager</b> ensures all usual building checks are undertaken to make the school building safe.</li> <li>• Where buildings have been closed or had reduced occupancy, water systems are checked.</li> </ul>	
<b>Are these controls now in place? – YES</b>	<b>By whom? SMT &amp; Site Manager</b>

## 12) TESTING

Risk rating prior to action – **HIGH**

Risk Rating following controls - **MEDIUM**

### Control Measures

- All testing is carried out in line with the [Coronavirus \(COVID-19\): Asymptomatic Testing Policy](#).
- **[Updated]** It is made clear that testing is voluntary. Individuals not undergoing testing attend school in line with normal school arrangements.
- **[Early years setting and primary schools only]** Pupils do not undergo testing.
- **[New]** Staff in all education settings are encouraged to test twice weekly at home until the testing guidance is reviewed in September.
- The school obtains written consent from staff to process and store their testing data prior to beginning testing.
- **[New] [Secondary schools and post-16 settings only]** All pupils receive two on-site lateral flow device (LFD) tests, three to five days apart, on their return to school in the Autumn term.
- **[Secondary schools and post-16 settings only]** The school obtains written consent from pupils, and their parents where required, to process and store their testing data prior to beginning testing.
- Individuals with negative test results continue to attend school unless they have been advised by NHS Test and Trace or another health professional to stay at home.
- Staff and pupils undergoing testing are supplied with LFD test kits to self-swab and test themselves twice a week at home.
- Staff, pupils and parents are fully informed of the testing programme.
- **[Updated]** Individuals report their results to NHS Test and Trace as soon as the test is completed, either online or by telephone.
- **[Secondary schools and post-16 settings only]** Pupils aged 18 and over self-test and report the result, with assistance if needed. Pupils aged 12 to 17 self-test and report their results with adult supervision. Pupils aged 11 are tested by an adult.
- **[Secondary schools and post-16 settings only]** The school retains a small on-site asymptomatic testing site (ATS) so testing can be offered to pupils who are unable or unwilling to test themselves at home.
- **[Updated]** Individuals who receive a positive result from an LFD test complete a 10-day period of self-isolation and are asked to arrange a confirmatory PCR test.
- Individuals who test positive using an LFD test arrange their PCR test within 2 days of the positive result. All positive results from LFD tests, whether conducted at home or at school, are confirmed with a PCR test.
- **[Updated]** Staff, pupils and parents are made aware that negative results from confirmatory PCR tests taken within 2 days of LFD tests override positive results from LFD tests; therefore, individuals who receive negative PCR test results can return to school, provided they do not have symptoms.
- Individuals do not take an LFD test if they have tested positive for coronavirus within the

last 90 days.

- Individuals are informed that LFD tests are not to be used if they begin to develop symptoms of coronavirus; they instead begin self-isolating immediately and book a PCR test.
- **[Updated]** Testing kits are stored indoors between a temperature of 2 to 30°C.
- Individuals are instructed to collect test kits from the designated collection point.
- A test kit log is in use and kept up-to-date with the relevant information required.
- A test result log is in use and kept up-to-date with the relevant information required.  
The data held in the test kit log and test result log is stored in line with the school's [Data Protection Policy](#) at all times.

### 13) NHS TEST AND TRACE

Risk rating prior to action – **HIGH**

Risk Rating following controls - **MEDIUM**

#### Control Measures

- **[New]** The school makes staff aware that is not responsible for Test and Trace contacting. This will be taken over by the NHS Test and Trace service.
- **[New]** The school makes staff aware that the NHS Test and Trace service will inform staff and pupils if they have been in close contact with a positive case of coronavirus and will advise them to take a PCR test.
- **[New]** The school continues to work with local HPTs in the event of a school or local outbreak.
- **[Updated]** Staff members and parents are informed that they will need to engage with the NHS Test and Trace programme if they are contacted, meaning they need to be ready and willing to:
  - Book a PCR test if they (or their child) display symptoms.
  - Provide details of anyone they (or their child) have been in close contact with if they were to test positive for coronavirus or are asked by NHS Test and Trace.
  - **[Updated]** Take a test if they have been in close contact with someone who develops coronavirus symptoms or someone who tests positive.
  - **[New]** Self-isolate if they display symptoms or produce a positive test.
- Anyone in school who displays symptoms is encouraged to get a PCR test.
- If the school believes a symptomatic individual may face barriers to accessing a PCR test elsewhere, the school provides them with a PCR test.
- PCR tests stored on the school site are stored securely at ambient room temperature (5 to 22°C).
- The school considers offering a symptomatic staff member a PCR test if they cannot otherwise access testing quickly and if the individual is vital to the running of the school.
- PCR tests are delivered safely and with due regard for transmission risk.
- **[Secondary schools and post-16 settings only]** Tests are not given directly to pupils but are instead given to the pupil's parent or carer.
- Individuals are asked to inform the school immediately of test results.
- If an individual tests negative, they feel well and no longer have coronavirus symptoms, they, and the members of their household, can stop self-isolating as long as:
  - They were not told to self-isolate for 10 days from the day after contact with the individual who tested positive by NHS Test and Trace.
  - They feel well.
- If an individual tests positive, they are required to self-isolate for at least 10 days from the onset of symptoms and then return to school only if they do not have symptoms other than a cough, or loss of or change in their sense of smell or taste. Other members of their household are required to continue self-isolating for the full 10-day period unless they are fully vaccinated adults or under the age of 18.
- Staff and pupils aged 16 and over are encouraged to download the NHS Test and Trace

app – rules on mobile phones in school are relaxed to accommodate this.

- Individuals are informed that, if they receive notification via the NHS Test and Trace app that they have been in close contact with a positive case, they must inform the school immediately.
- Individuals who test positive are encouraged to report the result on the NHS Test and Trace app.
- If a pupil receives notification to self-isolate, the school ensures appropriate arrangements are in place for the pupil to self-isolate when they are directed to, and begin remote learning.
- **[Schools with premises on site that are within the scope of the Health Protection (Coronavirus, Collection of Contact Details and Related Requirements) Regulations 2020, such as facilities open to the public, e.g. swimming pools and libraries]** The **Principal** ensures an NHS QR code poster is displayed in spaces open to the public and that a customer record is kept.
- If a member of staff receives notification that they need to self-isolate, the school will consider the action that needs to be taken to ensure continuity of education.

### Control Measures

- Clinically vulnerable and clinically extremely vulnerable (CEV) pupils are supported to attend on-site provision.
- Pupils who live with someone who is CEV continue to attend school as normal.
- All CEV pupils attend the school unless they have been advised by their GP or clinician not to attend.
- The relevant staff liaise with the parents of pupils who are deemed more vulnerable to infection and discuss their concerns and the infection control measures in place at the school.
- The school collaborates with the LA to ensure that alternative arrangements for CEV pupils are in place to prepare for the event that the school site is required to close.
- If CEV pupils are self-isolating and cannot attend on-site provision, procedures are put in place to maintain contact and make sure their parents know that the decision not to attend can be revisited at any time.
- CEV staff continue to work from home where possible. If this is not possible, they are supported to attend the school site.
- Clinically vulnerable staff continue to attend school provided they follow the [system of controls](#) to minimise the risks of transmission.
- Staff who live with those who are CEV attend the workplace but ensure they maintain good prevention practice in the workplace and at home.
- Line managers hold discussions with staff who are deemed more vulnerable to infection and discuss their concerns and the infection control measures in place at the school.
- The SLT considers requests made by staff who wish to make changes to their working environment or working hours in the interest of health and safety.
- If required, CEV staff can adjust their working hours, as agreed by the SLT.
- The **Principal** ensures that the school can be adequately and safely staffed.
- A separate risk assessment is carried out for pregnant staff. The school follows the relevant specific guidance for pregnant employees.
- Pregnant staff of any gestation are not required to continue working on site if this is not supported by the separate risk assessment.
- Staff who are 28 weeks pregnant and beyond, or are pregnant and have an underlying health condition that puts them at a greater risk of severe illness from coronavirus at any gestation, are supported to take a more precautionary approach.
- The school ensures pregnant staff are able to adhere to any active national guidance on social distancing and/or advice for pregnant women considered to be clinically extremely vulnerable.
- The above principles on protecting pregnant staff also apply to pregnant pupils.
- **[New]** The school encourages staff to get vaccinated if possible, and enables these staff members to attend booked vaccination appointments, even during term time.

<ul style="list-style-type: none"> <li>• The setting is not required to arrange children and staff in small, consistent groups.</li> <li>• Parents are encouraged to limit the number of settings their child attends.</li> <li>• Social distancing between groups of children and staff is implemented as far as possible.</li> <li>• The use of communal spaces is managed to limit the level of mixing between groups.</li> <li>• The use of private outdoor space is maximised to ensure social distancing measures can be adhered to.</li> <li>• Children are taken to outdoor public spaces, e.g. parks, in small groups, following the completion of a risk assessment that demonstrates they can stay at least two metres from people outside of their group at all times. This is done in line with wider government guidelines on the number of people who can meet in outdoor public places.</li> <li>• Children are supervised when washing their hands or using hand sanitiser and are taught how to do so effectively.</li> <li>• A good supply of disposable tissues is available throughout the premises and 'catch it, bin it, kill it' is encouraged through signage and prompting.</li> <li>• An enhanced cleaning schedule is put in place.</li> <li>• Surfaces, toys, books, doors, sinks, toilets and light switches are cleaned more regularly, using disinfectant, in line with the <b>COSHH Policy</b>.</li> <li>• Activities that involve malleable materials for messy play, e.g. sand, mud and water, are risk assessed.
